1. The Bidder shall quote price in clear terms. The rates quoted must be inclusive of all taxes, cost of supply at site, on site warranty and other charges if any.
2. The price should be quoted only in Indian rupees. The bid should be signed and sealed by the bidder.
3. Interested firm/contractor can inspect the site on working day between 10.30 am to 4.30 pm
4. The tenders without proper seal and sign will be rejected.
5. Validity: - The Bid will be valid for 90 days from its date of opening. Further extension can be done by mutual consent.
6. The selected bidder shall execute an agreement in the Stamp paper after remitting a security deposit @ 5 % of total price in the form of DD drawn in favour of Secretary, c-hed.
7. Safety: - All applicable safety standards and regulations shall be applicable. The bidder shall ensure the safety of workers and safety at site.
8. Payment: - c-hed will release the payment only after inspecting the work and after becoming satisfied the work done is as per the requirements and on the basis of actual quantity executed. The payment will be made after successful completion of the work on producing invoice.
9. Warranty/Guarantee: - The Guarantee period of the work is 12 months or the guarantee/warranty available on each products/component/part of work (whichever is maximum shall be applicable). The Firm shall guarantee to repair/replace the items or its parts -if found defective within the applicable Guarantee period. The entire expenditure for repair/ replace the item in this regard shall be borne by the firm. Guarantee shall be on site and is applicable for the entire item.
10. Forfeiture of Security Deposit: - The Security Deposit will be forfeited if the firm fails to complete the work as per the Work order. No payment will be made for any part of the completed works in the exist of failure of the bidder to complete the work.
11. Release of Security Deposit:- The security deposit will be released only after the successful completion of the six months from work completion date.
12. In case of dispute , the decision of c-hed shall be final and binding on bidders.
13. The undersigned reserves the right to reject any or all the tenders without assigning any reason thereof.
