- 1. GENERAL
- 1.1. Scope of the Bid:-
- 1.1.1. The Centre for Heritage, Environment, and Development invites bids from qualified companies/firms for the Work "SUPPLY AND INSTALLATION OF CCTV SURVEILLANCE SYSTEM AT PERUMBOTTA GROUND, ELAMAKKARA NORTH" detailed in the Notice Inviting Tender (NIT).
- 1.2 Cost of Bidding
- 1.2.1 The bidder shall bear all costs associated with the preparation & submission of bids and site visits, and the Authority will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- 1.2.2. The tender document(s), may be downloaded free of cost from the c-hed website (https://ched.org/category/homepage-news/).
- 1.3 Bid Prices
- 1.3.1 The Bidder shall bid for the whole work as described in the Bill of Quantities.
- 1.3.2 The rates quoted by the Bidder shall include cost of all materials and conveyance, labour charges, hire charges of plant and machinery, overheads and all incidental charges for execution of the contract. The rate quoted shall also include all statutory taxes as on the date of submission of the tender and such taxes shall be paid by the contractor
- 1.3.3 The rates and prices quoted by the bidder shall remain firm during the entire period of contract. The authority shall not accept any price escalated from the original quoted amount.



1.4 The successful bidder should guarantee the successful and satisfactory completion of the works under the contract, as per the specifications and documents.

1.5 The successful bidder further guarantees that the infrastructure and equipments provided and installed by him shall be free from all defects in material and workmanship and shall, upon written notice from the Agreement Authority or the Engineer, fully remedy free of expenses to the Employer, such defects as developed under the normal use of the said infrastructure within the period of defect liability of 1 year from date of completion of the work.

Terms and Conditions

- 1. **Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to submit undertaking to this effect with bid.
- 2. An Earnest Money Deposit (**EMD**) amount of Rs. 3000/- (Rupees Three Thousand Only) will be in the form of a demand draft drawn in favor of the Secretary, Centre for Heritage, Environment and Development (c-hed). EMD shall be released after signing of agreement and furnishing of security of 5% of Contract Amount.
- 3. EMD in the form of DD, Hard Copy of the DD must be submitted before bid end date along with the tender document.
- 4. The bidder must visit the site and thoroughly review the scope of work, site conditions, provisions in the tender documents, available resources, and any potential site-related difficulties or restrictions. Failure to do so and subsequently quoting a price that does not account for these factors, or facing any difficulties due to not visiting the site, will not be the responsibility of the authority. The authority will assume that the bidder has visited the site and submitted their quote based on their own inspection and evaluation. The bidder may contact the authority for any clarifications before submitting their bid.
- 5. Bidder must have given the rate all-inclusive of supplying & Installation, site clearance, civil work, MEP, Transportation, Loading-Unloading, taxes etc.
- 6. Payment shall be deducted for all norms, TDS and necessary govt taxes and etc.
- 7. GST Certificate, Registration certificate, will also be considered.
- 8. Attach details of previous works completed as provided in annexure
- 9. A minimum Warranty period of the supplied products shall be 1 year from the date of final acceptance of goods or after completion of installation.
- 10. Bidder's offer is liable to be rejected if they don't submit any of the certificates / documents sought in the Bid document.



- 11. Bid Validity (Total Number of Days up to which the rates are to be firm) 60 day
- 12. The Bidder should have valid GST registration and valid PAN/Taxation Index Number.
